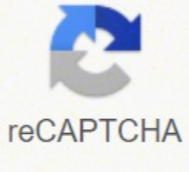
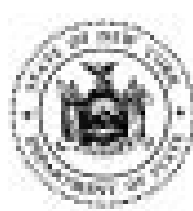

**New York State Disclosure Form for Buyer and Seller**

**THIS IS NOT A CONTRACT**

New York State law requires real estate licensees who are acting as agents of buyers and sellers of property to advise the potential buyers and sellers with respect to the nature of their agency relationship and the rights and obligations it creates. This disclosure will help you to make informed choices about your relationship with the real estate broker and to share decisions.

Throughout the transaction you may receive more than one disclosure form. The law requires each agent assisting in the transaction to present you with the disclosure form. A real estate agent is a person qualified to advise about real estate.

**Disclosure Regarding Real Estate Agency Relationships**

**Seller's Agent**

A seller's agent is an agent who is engaged by a seller to represent the seller's interest. The seller's agent does this by securing a buyer for the seller's home at a price and on terms acceptable to the seller. A seller's agent has, without limitation, the following fiduciary duties to the seller: reasonable care, undivided loyalty, confidentiality, full disclosure, obedience and duty to account. A seller's agent does not represent the interests of the buyer. The obligations of a seller's agent are also subject to any specific provisions set forth in an agreement between the agent and the seller. In dealings with the buyer, a seller's agent should (a) exercise reasonable skill and care in performance of the agent's duties; (b) deal honestly, fairly and in good faith; and (c) disclose all facts known to the agent materially affecting the value or desirability of property, except as otherwise provided by law.

**Buyer's Agent**

A buyer's agent is an agent who is engaged by a buyer to represent the buyer's interest. The buyer's agent does this

by negotiating the purchase of a home at a price and on terms acceptable to the buyer. A buyer's agent has, without limitation, the following fiduciary duties to the buyer: reasonable care, undivided loyalty, confidentiality, full disclosure, obedience and duty to account. A buyer's agent does not represent the interest of the seller. The obligations of a buyer's agent are also subject to any specific provisions set forth in an agreement between the agent and the buyer. In dealings with the seller, a buyer's agent should (a) exercise reasonable skill and care in performance of the agent's duties; (b) deal honestly, fairly and in good faith; and (c) disclose all facts known to the agent materially affecting the buyer's ability and/or willingness to perform a contract to acquire seller's property that are not inconsistent with the agent's fiduciary duties to the buyer.

**Broker's Agents**

A broker's agent is an agent that cooperates or is engaged by a listing agent or a buyer's agent (but does not work for the same firm as the listing agent or buyer's agent) to assist the listing agent or buyer's agent in locating a property to sell or buy, respectively, for the listing agent's seller or the buyer agent's buyer. The broker's agent does not have a direct relationship with the buyer or seller and the buyer or seller can not provide instructions or direction directly to the broker's agent. The buyer and the seller therefore do not have vicarious liability for the acts of the broker's agent. The listing agent or buyer's agent do provide directions and instruction to the broker's agent and therefore the listing agent or buyer's agent will have liability for the acts of the broker's agent.

**Dual Agent**

A real estate broker may represent both the buyer and seller if both the buyer and seller give their informed consent in writing. In such a dual agency situation, the agent will not be able to provide the full range of fiduciary duties to the buyer and seller. The obligations of an agent are also subject to any specific provisions set forth in an agreement between

Fortunately, the internal tax service (IRS) publishes a variety of ways to help taxpayers compile and inform the necessary information related to their taxes. While these forms can make your easier taxes to understand, there is also a great variety of them, and it is important to know what you really need if you are trying to streamline your presentation process. Some forms are for personal use to facilitate the presentation of your taxes. You will need to present others with your taxes, and some are designed for you to submit your employer. Each form has a specific proposition and incorporates different types of information, depending on what needs it. Here, we will discuss how these forms are, how to use them and what to know about some of the most common forms that will be found. Photo courtesy: Kemal Yildirim / Getty Images IRS Forms are filled documents that you use to track your financial activities or inform them to the federal government. Its general purpose is to provide the correct financial information necessary to calculate what it owes in taxes (or if it is due to a refund after the presentation). There are dozens of IRS forms to meet a variety of needs, but, depending on their financial situation, it is likely that it does not have to use more than a few each time it presents. Below are some simple descriptions of the most common tax forms that you can expect to be found: Form 1040 (United States Income Tax Declaration UU) It is used to inform your annual income. You will send this form to the IRS when taxes. Form 1099 (Miscellaneous Income) and all of its schedules are used to report income that does not come from a job with regular wages or a salary. This could include the work you did for a company as a freelance contractor, income from rent or investments, or money you won as a prize. If you earn income that is not automatically taxed, such as Freelancing income, you can use Form 1040-E (Estimated Tax for Individuals) to calculate how much of your earned income you are likely to owe the IRS in taxes. Many freelancers and others use this form for their quarterly tax filings. The W-4e (employee retention certificate) form is a form you send to your employer. It allows you to identify the number of dependents you are claiming for tax purposes and determine the money you want to withdraw from your paychecks. The details on this form allow your employer to determine the amount of federal income tax money to withhold from your paycheck. You can enter these details into the payroll software to calculate federal income tax deductions each pay period. Form W-9 (Identification Number and Taxpayer Identification Request Certification) provides an employer with their taxpayer identification number so they can properly identify you when they do so. Certain payments to the IRS. If you need an Individual Tax Identification Number (ITIN), you will send Form W-7 (Application for IRS Individual Taxpayer Identification Number) to the IRS. If you don't have a social security number, such as if you're undocumented or a permanent resident, you need an ITIN to file your taxes. Form 4506-TAe (Request for Transcript of Tax Return) is a form that is sent to the IRS so you can receive a tax transcript. This is a detailed accounting of a tax return you have previously filed, and you may need it for a personal audit or to submit it as proof for an income-based application, such as SNAP benefits. FORM (Wage Statement and Tax) is an annual accounting of all the funds your employer paid you in a calendar year. The employer provides you with three copies of the form, and file another copy of the form with the IRS. You'll keep a copy for your records, file a copy for state taxes if necessary and third copy for federal taxes. The forms in the 1095 series relate to individual health insurance coverage. For example, Form 1095-B provides details of the amount of government subsidies applied to your health insurance through the Affordable Care Act. If you owe you more taxes than you can pay, you can establish a payment agreement with the IRS. Form 9465a (subject to payment agreement) is the form you will use to do so. That's why there are several versions of common forms. For example, Form 1099 branches in Form 1099-NEC and Form 1099-MISC, each of which addresses more specific fiscal situations. Other IRS tax form programs and series have different uses, but it involves a similar topic. For example, the 1095-A, 1095-B and 1095-C forms relate to health insurance, but the different entities fill them, depending on how a taxpayer receives health insurance. To decide whether to use a certain schedule or series of a standard tax form, start with the most basic version of the document and read the instructions carefully. The IRS makes the forms easy to use. Many forms have a clear verbiage with the directives to alert you to additional forms you may need to send. For example, Form-1040 directs taxpayers to attach a form C program. If you need to report interest exempt from taxes or qualified investment dividends.
