## After Hours Availability of Medical Record – Documented Process

### After Hours Care

The Practice has a written process and defined standards and demonstrates that it monitors performance against the standards for providing continuity of medical record information for care and advice when the office is not open.

### Policy

It is the policy of the Practice that the medical record is available to Practice providers when the office is closed in order to provide timely and appropriate care.

### Procedure

The EHR system is cloud based such that all providers are granted access to the Practice's electronic health record system from any remote location that has Internet access if they are permitted to have off-site access per the site administrator. The Practice makes patient clinical information available to its on-call providers and to any external facilities for after-hours care through secure Internet access. Remote access is limited to those providers who require it.

Providers are responsible to create and maintain secure passwords according to the Practice's Internet security practices. All users change passwords on a semi-annual basis.

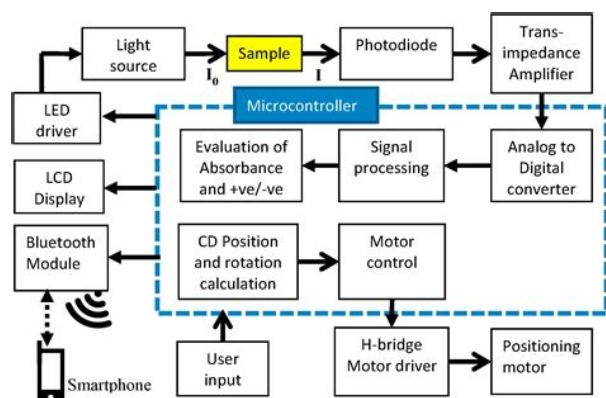
The Practice assures that its providers with after-hours access can view the individual care plans or portable personal health records of patients as well as patients' electronic health records.

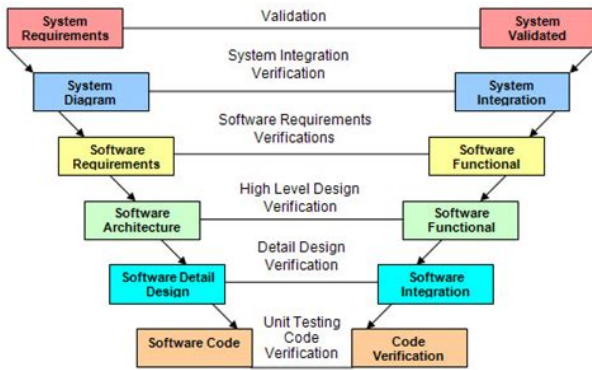
