In 1994, the District Court first issued a comprehensive and far reaching protocol for handling domestic violence cases throughout New Hampshire. Spawned by the growing caseload and need for consistency in handling these cases, the protocol became the first comprehensive, multidisciplinary set of guidelines for addressing domestic violence in New Hampshire. The protocols were revised again in 2002 and have been reprinted and distributed to hundreds upon hundreds of professionals throughout the State. The New Hampshire Supreme Court has also begun to develop a body of case law on domestic violence and stalking. Annually, the District Courts and Family Division are now hearing approximately 8,000 requests for domestic violence protective orders and stalking cases.
