There is additional testing required to obtain an endorsement and in some cases, if you already have

a CDL you will be required to hold a commercial learner permit for that endorsement for at least 14 days before being able to add it to your CDL. When applying for a CDL it will be necessary for you to understand what type of commerce you will be operating in so that the correct type of license can be issued to you. If you apply for an interstate commerce CDL, it will allow you to operate in both interstate and intrastate commerce, unless you apply for an interstate CDL specifically to operate within a certain capacity.
